

This is the true story of a legal battle (the trial itself took 7 weeks) between a respected corporation (Merck) and a man man consider the best trial lawyer (Mark Lanier) over whether Merck had adequately warned doctors and patients about heart attack risks associated with its Vioxx painkiller. The story begins by relating how Vioxx allegedly injured two individuals and killed a third, how those initially involved sought legal help, and then thousands of similar cases were consolidated from among the almost 20 million that had used it before Merck pulled the drug from the market. (A senior FDA scientist estimated Vioxx caused 88,000 - 140,000 serious cases, with almost half fatal.)Merck created a \$675 million legal fund in 2004, and by the end of 2006 had spent all of that plus an additional \$110 million. By the end of 2006 only 13 cases had been tried (first began in

2000), with Merck winning eight, two ending in mistrials, and the plaintiffs winning three. Merck then appealed all the cases it lost, and attempted to consolidate the remaining cases in federal court - easier to defend. Plaintiffs, however, managed to consolidate the majority of cases into a N.J. state court trial. That trial is the focus of the book.Lead attorney Lanier recognized he had to explain the science involved in simple terms, and that doing so required 25 - 30 such 'mini-lessons.' Lanier had made himself a student of such teaching, and believed only three such concepts/day could be absorbed and retained by jurors. (The federal trials were limited to three weeks - a length Lanier believed was insufficient for the complexity involved and teaching required.
