

Â Â Poulson also looks at what happens when a sport becomes a commodityâ "even a sport that may have begun as a reaction against corporate and professional sportâ "arguing that commodification inevitably plays a role in determining who plays, and also how and why the sport is played. It can even help provide the meaning that athletes assign to their participation in the sport. Finally, the book explores the intersections of race, class, and gender with respect to participation in lifestyle and endurance sports, noting in particular that there is a near complete absence of people of color in most of these contests. In addition, Poulson examines how concepts of masculinity in triathlons have changed as womenâ [™]s roles in this sport increase. Â Â
