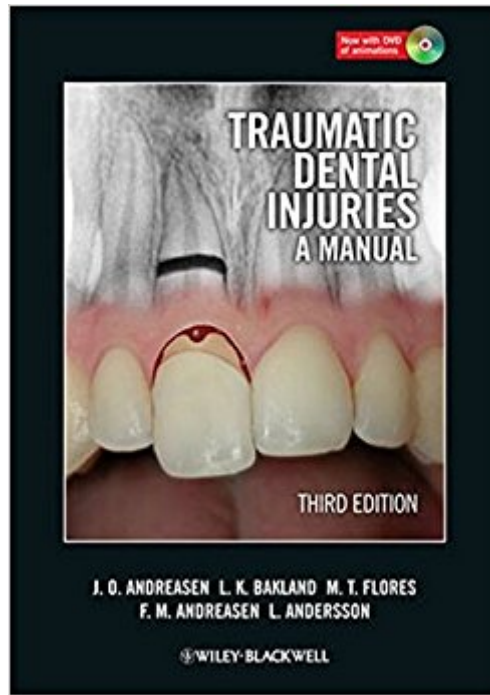

Synopsis
